The meeting began with a comprehensive COVID-19 report from President & CEO, Renée J. Bernasconi, to update the Council on how Seabury is navigating through this pandemic. This report was followed up by a state of the current Membership, active leads who are in the process of joining SAH and those who are in the process of moving to Seabury.

The bulk of the discussion was on the revision to the SAH Member Council Bylaws and planning for the Annual Meeting, which this year, will be held on **Thurs., Aug. 20, 2020**. While details remain unknown at this time as to how the meeting will take place — whether in-person or video conference — the main agenda items will be to approve the new Bylaws and to re-elect or elect Members to four director seats with expired terms.
